Research for SIFA (Safe Internet For All)



Research will be done in two ways. More general research with a pre-test (Nov 2014) and a Post-test (June 2016) and a smaller scale research before and after each short term meeting (Austria, Norway, etc.).

Research will serve as an intellectual output that is beyond plagiarism and upgrades the quality of the results, but it will also serve as a tool for internal evaluation. We have defined the

following research questions concerning 5 major problems/topics related to internet use (addiction, health, sequently, ethics, cafeby):

1st research question: Do students know what every problem (topic) is about? We will also check for awareness.

2nd research question: Have students experienced problem (the topic is about)?

3nd research question: Do students know what to do if they (or their friends) experience this?





Research Q1: Conclusions

internet use? (such as Plagiarism, Copyrights, Rights and Responsibilites, Violation, Cyberbullying, etc)

- About 30% does n't know about Plagiarism or about Legal Regulations
- About 20% seems to have some confusion about rights and responsibilities
- Nearly 50% seems to have some confusion about violation
- About 40% does n't know about Copyright

Research Q2: Conclusions

Mave students experienced some situation that might consist a violation of rights?

- About 15% does n't act according to the law, when uploading digital material
- Over 70% has violated some copyright law at some occasion
- About 42% does n't care about learning how to Copyright their work and 30% want to learn





Research Q3: Conclusions

recognized some violation of rights?

- When students were asked the first question, about 77% seem to know how to act; yet 15% do not and the rest are not sure
- When students were asked the second question, about 31% seem to know how to act and 49% act in a definitely wrong manner

- •Therefore the best answers were given by students from Poland and Sweden, average answers were given by students from Norway and Greece and less right answers from students from Austria (X² =34.602, *df*=4, p=.000)

- •Therefore the best answers were given by students from Poland, average answers were given by students from Sweden and Austria and less right answers from students from Norway and Greece (X² =89.820, *df*=60, p=.008)



General Conclusions







Conclusions 1/2

- **Culte a few of our students (30%-40%) seem to get confused or obviously don't know about Plagiarism, Legal Regulations and Copyright
- Also about 20% seem to have some confusion about rights and responsibilities
- Over 70% has violated some copyright law at some occasion → this is a problem!







Conclusions 2/2

- When asked questions about how to act when rights are violated, most seem to know how to act, yet 15%-30% do not (depending upon the question)
- Some interesting correlations were found regarding the Country of origin of the students and the answers they gave
- In the workshops you can try to interpret the previously mentioned results
